# **2023 ACCOMPLISHMENTS**

Raising and administering financial support for the Forest Preserve District of Will County is The Nature Foundation of Will County's mission. It is bolstered by a strong commitment to meeting the interests of its donors in supporting meaningful and impactful programs and projects that protect nature, inspire discovery and bring people and nature together.

### **Legacy Gifts**

In 2023, The Nature Foundation received \$450,000 in legacy gifts for preserve improvements at Lake Chaminwood Preserve as well as habitat restoration at Goodenow Grove Nature Preserve (GGNP).



The legacy gift received for habitat restoration at GGNP also creates a new Land Stewardship Fund which the Foundation will use to grow its commitment to restoring biodiversity and improving habitat in the Will County forest preserves. Initially, the Foundation hopes to provide matching dollars for grants that the Forest Preserve receives from national, regional, state, and local granting agencies.

### **Invest in Nature Corporate Partnership Projects**

In 2023, The Nature Foundation of Will County secured over \$62,500 in funding from corporations, businesses and foundations to support Forest Preserve District initiatives as well as the Foundation's native plant sales and its Bringing Nature Home Initiative.

- STEM & STEAM education programs at all Forest Preserve Visitor Centers with funding from Pembina, matched by gifts made to The Nature Foundation by its donors and supporters.
- Connecting Kids with Nature School Bus Scholarship Program with funding from Pembina.
- Community events including Eagle Watch, Migration Celebration, and Pelican Party at Four Rivers Environmental Education Center in partnership with Enbridge Alliance.
- Trout restocking at Hidden Lakes Trout Farm in partnership with Bass Pro Shops & Cabela's Outdoor Fund.
- New benches at Hidden Oaks Nature Center and Hidden Lakes Trout Farm in partnership with Vulcan Materials Company.
- Education and fishing program equipment and supplies for Hidden Oaks Nature Center in partnership with the Sgt. Thomas M. Gilbert Memorial Foundation.
- Supplies and equipment for volunteer community workdays and the Adopt-A-Preserve program in partnership with Target.
- Bicycle repair stations along the Hickory Creek Bikeway and the Veteran's Memorial Trail in partnership with the Joliet Bicycle Club, matched by gifts made to The Nature Foundation by its donors and supporters.
- Support for native plant sale events and the Bringing Nature Home Initiative in partnership with Enbridge, Brent Hassert Consulting LLC, Nicor, Pizzo & Associates LTD, Pizzo Native Plant Nursery, PuroClean of Romeoville, CBBE, JULIE Inc., KGG LLC, A.J. Dralle Inc, Strand Associates, Village of Romeoville, and Uni-Max Management Corporation.

### **Organizational Development**

The Nature Foundation of Will County's capacity to accomplish its mission and meet the interests of its donors relies on solid fundraising and investment strategies, a growing donor base, an engaged Board of Directors, a growing community of volunteers, a strong leadership team, and a commitment to organizational development.

In 2023, the Foundation has made progress in each of these areas and in response to growing interest and support, it has taken the necessary steps to add new staff which is essential to managing its growth.

The Foundation has made progress on reaching many of the benchmarks it set in 2023 outlined below:

#### **Fundraising & Projects**

- 1. There is a constant and diversified stream of funding from a variety of sources.
- 2. Donors are engaged and our donor base is ever-growing.
- 3. Donors are motivated to give planned gifts.
- 4. The Foundation is able to provide significant funding to the Forest Preserve District for its programs, projects and initiatives.

#### Finance & Investment

- 1. There is a constant and diversified stream of funding from a variety of sources.
- 2. The Foundation is able to invest and earn interest income.
- 3. The operating reserve ratio is 1.5 to 2.
- 4. The program expense ratio is 75%.
- 5. Meet or exceed a 10% to 15% profit margin.

### **Board Development**

- 1. Board members represent diverse communities and have a diversity of experiences and interests.
- 2. Board members are engaged and active in their roles as directors, officers, committee chairs and committee members.
- 3. The Board Development committee is able to fill board member vacancies as needed.
- 4. Board members feel supported and valued.

### **Volunteerism & Community Engagement**

- 1. There is a collaborative relationship with Volunteer Services.
- 2. Experiences with the Foundation are positive.
- 3. Volunteers seek out Foundation assignments, programs and projects.
- 4. Foundation opportunities enhance the Forest Preserve's volunteer program.

### Leadership & Governance

- 1. The Foundation is modeling best practices in non-profit governance.
- Daily administration and management creates a smooth-running organization.
- 3. Committees and work groups are self-guided and highly motivated to accomplish their goals.
- 4. The Foundation is trusted and respected among its donors, supporters and peer organizations.
- 5. The Foundation has key staff in leadership roles.

Transition the leadership and management of the Foundation to its new Executive Director following the retirement of its former Executive Director and implement the new contractual Program Coordinator position. Continue to grow volunteer involvement and support.

### Stewardship Development

Place a greater emphasis on stewardship efforts for all Foundation stakeholders including donors, corporate partners, volunteers, and board members.

### **Financial Development**

Place increase emphasis on growing unrestricted gifts and funding the Foundation's mission while continuing to invest and grow assets, provided the climate is favorable.

### **Legacy Development**

Complete development of the Legacy Society and Founder's Circle and continue to promote the benefits and impacts of legacy giving.

### **Invest in Nature Partnership Development**

Continue to engage the business community in multiple ways and grow support for the Foundation and its initiatives as well as for Forest Preserve District programs and projects.

### **Board Member Development**

Develop and implement an orientation, training and leadership development program for new and existing board members. Explore the possibility of holding hybrid board meetings.

### Storytelling Development

Develop a storytelling approach in the Foundation's marketing and communications strategies that focuses on sharing donor impacts, celebrating achievements, highlighting important issues, and honoring its donors and partners.
